Metro North showcasing excellence at the 2025 Innovation Showcase

Last Friday, Metro North hosted the 2025 Innovation Showcase, with nearly 200 staff from across our health service registering to attend. The event featured a diverse range of presenters showcasing clinical and service excellence, with a strong focus on transforming clinical care through innovation, translating knowledge into practice, and leveraging technology to drive improvement.

The packed event program featured 15 oral abstracts, a live recording of the Simulcast podcast, a spotlight on Metro North's Older Persons Emergency Network (OPEN), nine lightning presentations, interactive workshops, a mini-innovation ideation session, and a guest presentation from our colleagues at Cairns and Hinterland HHS.

The two keynote speakers on the day encouraged provocative reflections on the use of human centred approaches in innovation. There was thought provoking discussion on the use of AI to support innovation, and reflections on the benefit of putting ourselves - as leaders of innovation - in the shoes of our end users, to simulate their experiences and translate this knowledge into practice.

The presentation themes reinforced that while innovation can be technology-driven, it can also be grounded in practical, back-to-basics thinking that equally transforms patient care.

Dear team,

Here at Metro North Health, we are committed to providing safe, effective, high-quality and person-centred care. As part of this commitment, there are Clinical Governance systems and processes in place to deliver and measure the services we provide and foster an environment of continuously improving healthcare.

One of the ways we can measure our performance is using audit data. Currently there are

numerous audits that are conducted across Metro North Health to measure performance against the National Safety and Quality Health Service (NSQHS) Standards. I know many of you are already involved in completing these audits and I want to acknowledge and thank you for the important work.

Whilst these tools have provided valuable insights locally, the lack of standardisation has made it difficult to compare results, benchmark performance and fully understand how Metro North Health is performing against the NSQHS Standards. To address this, a Metro North Health National Standards Audit Framework is being developed, with the aim to facilitate standardised auditing for benchmarking, reporting and improvement purposes across Metro North Health. This framework will deliver a suite of standardised audit tools for use across Metro North Health, and an organisation-wide audit schedule, which will ensure the data we collect can be used to its full potential. The audit system that will be used for auditing under this framework is the Measurement, Analysis and Reporting System (MARS). MARS is used widely across Queensland Health and other healthcare organisations across Australia, and you may have used this system elsewhere.

A pilot of the Metro North National Standards Audit Framework is planned for the last quarter of the year, using three pilot audit tools.
