Queensland Health does not permit alterations to the Poster, such as design changes, re-branding or addition or removal of logos. Use of the photographs from the Poster will not be permitted separately from the Poster. Queensland Health may consider, on request and at its discretion, adaptations to the poster following submission of a draft or details of the intended adaptations.

Although alterations to the Poster are not generally permitted, Queensland Health may consider, on request and at its discretion, permitting adaptations and translation of the text of the Poster into other languages. Queensland Health may impose conditions on such permission including that:
