Consumers in Research Startup Grant



Introduction

The Royal Brisbane and Women's Hospital (RBWH), with the generous support of the RBWH Study, Education and Research Trust Account (SERTA) Advisory Committee, aims to provide financial support for consumer leadership, codesign and partnership in research project development at RBWH via a Consumers in Research Startup Grant.

A key objective of the Consumers in Research Startup Grant scheme is to facilitate increased consumer partnership in RBWH research studies from the time of study conception and initial development, such as consumer involvement as an investigator or advisor, leading to better study design, including research grant submissions that have had consumer partnership in their development.

As defined by Health Consumers Queensland, consumers are people who use, or are potential users, of health organisations including their family and carers. For the purposes of this grant scheme, a consumer is not a Metro North Health staff member, however, may be a Metro North Health consumer representative. It is intended that this grant scheme will enable consumer participation at the highest levels of involvement in research, such as consumer leadership and consumer participation, where consumers are responsible for leading major activities associated with the project or have shared responsibilities with other members of the research team.

Funding

The Consumers in Research Startup Grant scheme provides funding for consumer reimbursement of up to \$785 per project. The following line items, which may vary depending on the project, indicate how the maximum consumer remuneration per project (\$785) has been determined:

- 3 x 1-2 hr meetings = \$95 x 3 = \$285
- 2 x 2-4 hrs protocol or grant writing/review = \$190 x 2 = \$380
- Car parking x 3 meetings = \$40 x 3 = \$120

Expenditure of the Consumers in Research Startup Grant must be used for consumer reimbursement in the study design phase of the project, i.e. prior to Site Specific Authorisation or Quality Improvement study approval to proceed.

Consumer reimbursement must follow the Metro North Health "Partnering with consumers – reimbursement and payment" Procedure. Co-design activities may be funded as special payments, i.e. activities where a significant amount of preparation, data analysis, and reading is anticipated.

Eligibility

The lead applicant must meet the following eligibility criteria to apply for a Consumers in Research Startup Grant:

- Be an RBWH staff member with a minimum substantive appointment of 0.2 FTE, or
- Be an RBWH consumer representative, and

• Plan to be an investigator on a proposed (a) research project that will be submitted for Human Research Ethics Committee [HREC] review and Site Specific Assessment (SSA) authorisation (if required) as per the Metro North Health "Research" Procedure, or (b) quality improvement study that will be submitted for an exemption of HREC review (note: eligible quality improvement studies must be conducted at RBWH).

For applications involving multi-institutional research collaborations, evidence must be provided that the proposed research project will involve or benefit RBWH patients, consumers or staff.

Successful applicants will be required to submit a Consumer Engagement Expense Claim Form via RBWH Research Services for processing of consumer payments and to enable financial record keeping.

Grant recipients will be required to submit a report on the project status at 12 months from approval of funding, including project status, HREC/site approval and any grant funding submissions and the outcome (see pages 5 and 6).

Applications can be submitted at any time to RBWH Research Services, and a decision will be made as soon as possible. Applications will be reviewed against eligibility criteria with one of three outcomes sent to the lead applicant by email:

- 1. Supported for funding (note: multi-institutional collaborations may be awarded partial funding),
- 2. Not supported for funding with the reason provided (note: this may include the funding allowance for the scheme has been exhausted), or
- 3. Further information is requested before a decision is made.

RBWH Research Services, including the Research Services Manager and the Director of Research, RBWH, are the decision-makers for all applications received (excluding where direct conflicts of interest exist). All queries and correspondence regarding applications should be via RBWH_Grants@health.qld.gov.au; no further correspondence will be entered into once a final decision has been made.

Instructions for submission

- 1. Complete all sections of the Application Form (pages 3 and 4).
- 2. Obtain the necessary signatures (or an email confirming support).
- 3. Scan the signed Application Form, including any relevant attachments.
- 4. Name the scanned document:
