The Allied Health Professions (AHP) service line comprises Audiology, Nutrition and Dietetics, Occupational Therapy, Orthotics and Prosthetics, Physiotherapy, Psychology, Rehabilitation Engineering, Social Work and Speech Pathology, as well as the Clinical Multimedia Unit and Aboriginal and Torres Strait Islander Health Liaison Service. Allied Health is committed to the integration of research within clinical care and actively contributes to the achievement of the RBWH vision to be a world class academic health centre. This research investment, along with ongoing education, underpins the evidence base, effectiveness, and efficiency of our service delivery, and outcomes are aimed at transforming clinical service delivery within the rapidly changing healthcare environment.

The COVID-19 pandemic challenged service delivery, improvement and research in ways that we could only have dreamed of. Allied health researchers rose to the challenge, initiating research to identify which service changes during COVID-19 should be continued (or discontinued) in the post-COVID world. Despite the impact of COVID-19 on our clinician-researchers, our research outputs in Allied Health have remained strong, with highlights including:

\$2.1M of research funding awarded in 2020

10 research awards, including two awards at the MNHHS Research Excellence Awards

65 peer-reviewed publications including one book chapter ·

53 conference presentations, including 32 presentation at national and international conferences

46 research positions (funded research coordinator positions, conjoints and honorary appointments)

In 2020, 30 of our RBWH Allied Health Practitioners were enrolled in a research higher degree (RHD). We had four clinicians, Dr Michelle Cottrell (Physiotherapy), Dr Yvette Forbes (Psychology), Dr Laura Moroney and Dr Leisa Turkington (both Speech Pathology), complete their PhD in 2020. Our experienced researchers are involved in the supervision of an additional 23 RHD students across multiple universities; many of these students undertaking vital research that contributes to enhanced service delivery and patient care.

We appreciate and thank the contribution of all our university partners and collaborators across MNHHS and RBWH service lines, without whom this level of research success would not be possible and look forward to their ongoing collaboration. Finally, and most importantly, sincere thanks and congratulations are extended to all Allied Health staff for their dedicated efforts and achievements in 2020.

Centre for Allied Health Research

The Centre of Allied Health Research continued to support research capacity building through the Allied Health Professions (AHP) service line in 2020, including:

- Ieadership and success in the 'Allied Health Translating Research into Practice' (AH-TRIP) program, with two publications on building capacity for knowledge translation and two RBWH AHPs finalists in the state-wide showcase. This has also led to our contribution in a NHMRC Partnership Grant with university partners to use AH-TRIP to support speech pathology clinicians in implementing a new evidence-based treatment model for aphasia.
- ongoing research and evaluation of local research capacity building, including undertaking the bi-annual Research Capacity in Context survey in January 2020, to inform further implementation and progress of CAHR, the research strategies of individual departments, and research into the value of clinician-scientists to health services
- continued advocacy for increased consumer engagement in research and improvement, with grants awarded in 2020 to co-design improved service delivery models in the 'Mowbli' allied health maternity project (MNHHS Better Together grant) and develop a consumer engagement framework for service co-design (MNHHS SEED grant)
- enabling collaborative research across disciplines and service lines, including evaluation of rapid implementation of telehealth for RBWH allied health outpatient services during the COVID19 (involving all AHP departments and collaboration with RBWH Outpatient Services) and a project to test a new method for collating research metrics using REDcap in collaboration with MNHHS Allied Health, Metro South Research and the Queensland Children's Hospital.

Department of Nutrition & Dietetics

In 2020 the Department of Nutrition & Dietetics saw two staff members complete their PhD, one awarded a MNHHS Clinician Researcher Fellowship, two awarded RBWH Postdoctoral Fellowships and three won research awards across local, district and State-wide events. The department was awarded \$300,000 in research grants in 2020, and published 31 peer-reviewed papers, of which 12 were primary authors from the department. Despite the impact that COVID-19 had on conferences in 2020, several virtual conferences were held, and the department was represented by 8 oral presentations, including 2 invited presentations, and a total of 24 poster presentations. Research capacity is continuing to grow and develop in the department, with eight staff members who have completed a Research Higher Degree, four staff members who are enrolled in a Research Higher Degree, and three honorary appointees enrolled in a Research Higher Degree. There were five Honours research students from QUT and four Masters research students from UQ who completed their research projects in the department in 2020.

Department of Occupational Therapy

The 2020 year was an enormous year for RBWH Occupational Therapy, as we played our part in preparing for COVID-19, adapted our models of care and revised our research activities to meet strict social distancing requirements and ensure patient and staff safely.

Research momentum has grown in Occupational Therapy at RBWH over the past 12 months. Our Occupational therapy researchers have intensified their efforts to create new knowledge and translate that knowledge into patient care.

Our research efforts have been focused around three theme areas:

- 1. new technologies (vacuum therapy, telehealth, virtual reality, upper limb robotics)
- 2. Consumer engagement
- 3. Neurological research which seeks to enhance clinical design making in functional cognition, ecological assessment of cognition and life skills rehabilitation

Highlights for Occupational Therapy in 2020 include:

- 7 RBWH Foundation Scholarships awarded in 2020 1 new, 6 renewals
- 12 peer reviewed publications
- 4 oral presentations at National and International Conferences
- ✤ 4 poster presentations at National Conferences
- 3 staff are undertaking a PHD
- 5 staff are undertaking a Master's Degree
- \$1,034,271 of competitive grant funding

The RBWH Occupational Therapy Department continues to grow their collaborations with the UQ School of Health and Rehabilitation Sciences, UQ School of Engineering and Computing, RECOVER Injury Research Centre, Griffith University, Jamieson Trauma Institute and the Herston Biofabrication Institute.

Emeritus Prof Jenny Strong also shared her research skills more broadly across the HHS as she worked in the halftime position of Acting Executive Director Research for Metro North. Jenny was instrumental in the receipt of an MRFF RART grant which to improve health professionals' communication skills with First Nations peoples.

Department of Physiotherapy

In 2020, the Physiotherapy research programme continued to strengthen its research and quality activities across both inpatient and outpatient settings. Our team-based quality improvement initiatives continued from last year, which supported research & quality improvement activities across all 12 clinical streams within the department. To highlight this work, the RBWH Physiotherapy Department Research Symposium was held virtually over three lunchtime sessions, where 28 projects were presented to staff from across Metro North.

Overall, in 2020 there were 69 research projects undertaken where a member of the Physiotherapy Department was the Project Lead, and an additional 24 projects undertaken in collaboration with other departments/facilities. One staff member successfully completed their PhD, while three others continue their PhD journey. Research activities led to 14 peer reviewed publications, 8 national and international conference presentations and involvement in close to \$630 000 grant funding. Now in its third year, a further six research grants were distributed to clinicians of the Physiotherapy Department through the Physiotherapy Research Fund. Our General Surgery Pre-admission team were awarded the Overall superior Quality Achiever for 2020 at the RBWH QuARRIES as well as the Herston Symposium Translational Research Award, while two other staff members received awards at a national or international conference.

The Physiotherapy Department continues to develop strong research collaborations with universities with ongoing support for existing Conjoint Research Fellow positions with the University of Queensland (A/Prof Shaun O'Leary) and Griffith University (A/ Prof Jenny Paratz). Through research higher degrees, collaborations have also been forged with Queensland University of Technology and the Australian Catholic University. These collaborations have subsequently led to the RBWH Physiotherapy Department being a participating site in two NHMRC Project Grants in 2021.

Department of Rehabilitation Engineering, Orthotics and Prosthetics

Despite the many challenges of 2020 the Rehabilitation Engineering and Orthotic and Prosthetic teams continued to make progress in their emerging research journeys. Both departments have been focusing on developing the skills and supports in the teams to increase both the quality and quantity of research undertaken in the teams.

The Jamieson Trauma Institute funded rehabilitation engineering lead project to investigate using advanced manufacturing technologies to fabricate custom seat cushions was successfully completed and demonstrated promising results. The project resulted in a paper submission and follow up grant application aimed at continuing this exciting work.

Dr. Stephanie Fountain was also successful in receiving AHTRIP funding to progress research in outcome measurement in rehabilitation engineering.

Rehabilitation Engineering and Orthotics and Prosthetics staff were both active in grant applications to several funding bodies.

Orthotics and Prosthetics continues to develop a range of research questions related to current practice and to support expanding services

Unfortunately, with so many events impacted by restrictions this year, the normal opportunities to present outcomes and progress at conferences were not available. We are hoping for a big 2021!

Department of Social Work

Highlights of 2020 include:

- The successful implementation and evaluation of a preadmission social work model of care, which was selected for presentation at the Queensland Health AH-TRIP Virtual Showcase in December.
- An ongoing collaboration with Griffith University and Women's and Newborn Services to promote meninclusive maternity services, which included investigating men's experiences of attending RBWH Maternity Services. The project team interviewed over 40 men and will use the findings to inform the development of strategies for creating a more inclusive environment for fathers attending Maternity Services.
- Collaborating with the University of Queensland on a project to address elder abuse, which culminated in the awarding of an Australian Research Council Discovery grant to develop more effective social work interventions to break the cycle of abuse. The study will take place over three years and, importantly, will include the voices of older people who have been abused.

Department of Speech Pathology and Audiology

The Speech Pathology and Audiology Department has continued to progress and expand their clinical research programs throughout 2020. Speech pathology research focuses on clinical care and service models to enhance the provision of swallowing and communication intervention across cancer care, acute and critical care, stroke, neurology, and neurorehabilitation. The Audiology program encompasses research examining cochlear implant surgery and hearing and ear-health in First Nations People. Our departments are dedicated to embedding research into clinical services, expanding the evidence base for clinical practice, and research translation.

We have continued to grow our collaborations and value our research partnerships with UQCCR, UQ School of Health and Rehabilitation Sciences, RECOVER Injury Research Group and QUT. The establishment of the Queensland Aphasia Rehabilitation Centre, as a key clinical research centre within the Surgical Treatment and Rehabilitation Service, has facilitated new research collaborations which will see the development and evaluation of new treatments and service models to enhance the delivery of post-stroke aphasia care.

Speech Pathology Department research highlights for 2020 include -

- Dr Laura Moroney and Dr Leisa Turkington had their degrees conferred by The University of Queensland
- Dr Clare Burns received Highly Commended in the Rising Star category at the Metro North HHS Research Excellence Awards
- Continued supervision of research higher degree students including 4 department staff Penni Burfein, Ellie Minchell, Shana Taubert, Sarah Wilson who are supported by RBWH Post Graduate Research Scholarships
- New innovative research projects commenced in collaboration with academic and clinical service partners including the implementation of a new intensive aphasia treatment model, examining return to work for stroke survivors with aphasia, development of an intra-operative language testing battery for patients with brain tumours, evaluation of a mobile application for swallowing rehabilitation, and the development of a virtual reality tool for the treatment of communication disorders.
- Dissemination of speech pathology telepractice research and service models supported the delivery of clinical care during COVID-19 through a series of invited international webinars and recorded webisodes for Speech Pathology Australia by Dr Clare Burns & Professor Liz Ward, and collaboration with RBWH Allied Health Departments to establish, expand and evaluate telepractice services.

Audiology Department research highlights for 2020 include -

Leading PhD research being conducted by Alice Pender is examining hearing loss in Aboriginal and Torres Strait Islander adults. Her studies include a scoping systematic review to examine current research in the field; a qualitative study on the attitudes, knowledge, and experiences of hearing loss in Aboriginal and Torres Strait Islander adults and health professionals; and the examination of the rates of self-reported hearing loss and follow-up. The outcomes from these studies will inform future research to improve the management of hearing loss in Aboriginal and Torres Strait Islander adults.
