The Allied Health Professions (AHP) Service line includes Audiology, Nutrition, Dietetics and Food Services, Occupational Therapy, Orthotics and Prosthetics, Psychology, Social Work and Speech Pathology, as well as the Clinical Multimedia Unit and Aboriginal and Torres Strait Islander Health Liaison Service.

In 2022, AHP service line staff led and contributed to research achievements that included:

- 39 new research grants, totalling over \$18 million dollars (multi-year and in collaboration with multiple partners including UQ/STARS) to fund research and translation of research into practice that will directly improve patient care;
- 100 journal articles and 5 book chapters;
- 16 research awards; and
- 14 keynote or plenary lectures at national and international conferences.

These research outputs and success reflect the ongoing commitment of staff to embed research alongside clinical care and support from research coordinators, champions and directors who continually promote and encourage a research active workforce. In May we congratulated Professor Merrilyn Banks who won the Research Support Award at the Metro North Research Excellence Awards for recognition of her leadership in building research capacity across RBWH and Metro North.

Our leadership in consumer-focussed research and quality improvement was recognised at the 2022 QuARRIES, with three allied-health projects winning awards:

- Fostering Innovation RBWH Speech Pathology Led Referring Model.
- Consumer Engagement & Allied Health Service Line awards Co-designing a person centred PREMs framework.

Our service-line research capacity continues to grow and we congratulate Dr Shana Taubert (Speech Pathology) and Dr Erin Crofton (Occupational Therapy), respectively on conferral of their PhDs, and congratulate Dr Sarah Andersen (Nutrition & Dietetics) and Dr Julie Adsett (Physiotherapy) on receiving Metro North Clinician Research Fellowships, to support their post-doctoral research.

I want to express my thanks and acknowledge the essential role of our university partners in supporting our research activities and highlight major research grants that connect RBWH clinical services with national and international research collaborations, specifically:

- Professor Ruth Hubbard (UQ) and Dr Adrienne Young (UQ & Nutrition & Dietetics) and team, who were awarded MRFF Dementia Ageing and Aged Care and NHMRC Centre for Research Excellence funding;
- Professor Nadine Foster (UQ) and A/Professor Shaun O'Leary (UQ & Physiotherapy), Dr Maree Raymer and Patrick Swete Kelly (Physiotherapy), joining an international team to receive a NHMRC-NIHR Collaborative

#### Research Grant; and

• A/Professor Shaun O'Leary, Janelle Hein and Dr Michelle Cottrell (Physiotherapy), who were awarded a HCF Translational Research Grant to investigate best practice management of low-back pain in the Emergency Department, in partnership with the Emergency Trauma Centre and Jamieson Trauma Institute.

We appreciate the collaborative nature of our MN research partners including the Herston Bio fabrication Institute, Jamieson Trauma Institute as well as our ongoing, strong interdisciplinary partnerships across the RBWH Service Lines. I'd like to thank our consumer research partners, particularly Anja Christoffersen, Gary Power and Dale Trevor for supporting several allied health research projects. These research partnerships are fundamental to ensuring our research is aligned with best clinical practice and is for the benefit of patients and the community.

### **Centre for Allied Health Research**

## Research highlights for the year (1 January – 31 December 2022)

In 2022, the Centre for Allied Health Research supported research activity and translation of research into practice across the RBWH AHP service line and RBWH more broadly. We are proud to have supported high impact, collaborative projects, including the Metro North Telehealth Co-Design Project which will continue to uplift and sustain access to telehealth for patients across Metro North. We celebrated as the partnership between RBWH AHP and Safety and Implementation Service to co-design a person centred PREMs framework was awarded the Consumer Focus Category and the Allied Health Service Line QuARRIES awards.

We refreshed and updated the RBWH Allied Health Research Action Plan (2022-25), which will ensure a cohesive and strategic approach to building research capacity and outcomes over the next three years. Highlights included coordinating a Research Grant Writing Workshop in May 2022, where 20 participants joined our panel of experienced researchers and consumer representatives to learn strategies to support their own grant writing practice.

As 2022 concluded, we met with consumer representatives, allied health research coordinators, champions and managers to understand what is needed to make consumer-partnered research a reality for our service line. This codesign workshop was a highlight of our year as we could (finally!) meet face to face and understand the goals, barriers and solutions required to support genuine consumer-researcher partnerships for research and quality improvement. There will be more to come in 2023 as we put these strategies into practice.

Dr Abigail Marsh	Anti- inflammatory diets in adults with inflammatory bowel disease	December 2022	University of Queensland	The aim of this thesis was to investigate the effect of dietary patterns on disease activity in adults with inflammatory bowel disease (IBD). The thesis includes three key studies; a literature review, cross-sectional study and RCT designed to investigate the effects of following an anti-inflammatory diet on disease activity, symptoms, quality of life and gut microbiota composition in individuals with IBD. Overall, thesis findings support the implementation of an anti-inflammatory diet, low in food additives, in individuals with IBD. However, research on diet and IBD is still in its infancy and larger studies are needed to confirm pilot study findings.

# **Occupational Therapy**

# Research highlights for the year (1 January – 31 December 2022)

Occupational Therapy research continues to focus on translating or generating new evidence to improve our patients' hospital care, health outcomes and re-engagement with peoples' life roles i.e. "occupations".

Highlights for Occupational Therapy in 2022 include:

- 25 conference presentations at National and International meetings
- 5 peer reviewed publications
- 2 research awards recognising the achievements at a local and international level
- Dr Erin Crofton PHD conferred, University of Queensland: Sensory sensitivities and adherence with compression therapy after burn injuries

#### Areas of research this year;

- 1. Person centred outcome measurement for hand burn injury
- 2. Technology solutions as an adjunct to upper limb rehabilitation
- 3. Participating in life roles for consumers with persistent pain
- 4. MDT Teleburns Service
- 5. Impact on Occupational Performance following mild traumatic brain injury
- 6. Enhancing Occupational Performance in Distal Radius Fractures

Dr Nicole Andrews project was the first research study in Australia that aimed to improve safe driving among individuals with chronic pain. This project resulted in a change to national guidelines and were cited in the Austroads Assessing Fitness to Drive Guidelines. The national driver medical standards, Assessing Fitness to Drive, set out the considerations and medical criteria for safe driving. These standards are used by health professionals across Australia to assess and manage patients with health conditions that may affect their ability to drive safely. These assessments and the standards themselves inform Driver Licensing Authority decisions about driver licensing.

International recognition of Andrea Mc Kittrick's leadership in Burns care was awarded by the International Society for Burns Injury through the Andre Zagame Rehabilitation Specialist Prize.

The RBWH Occupational Therapy Service continues to grow their collaborations with the Herston Biofabrication Institute, UQ School of Engineering and Computing, RECOVER Injury Research Centre and Griffith University.

Occupational Therapy would like to acknowledge Emeritus Professor Jenny Strong who retired after five years of significant contribution in the Inaugural RBWH Occupational Therapy Research Co-ordinator role. The legacy of a vibrant and growing research culture will continue to benefit the profession and the care it brings to consumers of the Royal Brisbane and Women's Hospital.

# **Physiotherapy**

## Research highlights for the year (1 January – 31 December 2022)

In 2022, the Physiotherapy research programme continued to strengthen its research and quality activities across both inpatient and outpatient settings. The department's research focus has been demonstrated through both teambased research and quality improvement initiatives across all 11 clinical streams and individually led research projects. The department's outputs were showcased at our annual RBWH Physiotherapy Department Research Symposium, held virtually over three one-hour sessions. A total of 20 projects were presented at the Symposium with approximately 70 attendees from within the department and also... to staff from across the Herston precinct and Metro North.

A total of 77 research projects were undertaken across the department, including 57 with a Physiotherapy Department staff member as Project Lead, and 20 projects undertaken in collaboration with other departments/facilities. This was reflected in over \$3.7M in grant funding being awarded towards 29 current research grants, including four research grants distributed to clinicians of the Physiotherapy Department through the Physiotherapy Research Fund. We had 22 peer reviewed journal articles published, and five staff members continue to progress their post graduate research studies. The department's research success has also been highlighted through awards to Anita Plaza (Best Care oral presentation award; Annual scientific Meeting of the Australian and New Zealand Burn Association), Emilie Amiss (Dr Stephen Morrison award for Best Clinical Research; Herston Health Precinct Symposium) and Dr Peter Thomas (Local CAHRLI Award; Metro North CAHRLI Awards). As a clinical impact spotlight, Dr Thomas was lead author of the paper 'Physiotherapy Management for COVID-19 in the acute hospital setting: clinical practice recommendations', an update which was published in January 2022 and has been endorsed by World Physiotherapy as a leading COVID-19 Physiotherapy resource.

The Physiotherapy Department continues to develop strong research collaborations with universities with ongoing support for existing Conjoint Research Fellow positions. A/Prof Shaun O'Leary continues in his appointment with the University of Queensland, while Dr Samantha Bunzli was successfully appointed to the Griffith University conjoint position. Through research higher degrees, collaborations have also been forged locally (for example with Queensland University of Technology, University of Queensland and the Australian Catholic University), and internationally (University of Alberta, Canada).

## **Speech Pathology and Audiology**

### Research highlights for the year (1 January – 31 December 2022)

Across 2022, the Speech Pathology and Audiology Department has continued to grow its clinical research program. Our speech pathology research focuses on patient-centred clinical care and innovative service models to enhance swallowing and communication intervention across inpatient and outpatient services in cancer care, internal medicine, surgery and perioperative services, stroke and neurology, and gender services. Our audiology research focuses on improving access to care for Aboriginal and Torres Strait Islander adults living in Queensland and for our clients with cochlear implants.

A key research highlight for 2022 was Dr Shana Taubert and Dr Jasmine Foley being awarded their Doctor of Philosophy degrees from The University of Queensland. Both Shana and Jasmine conducted their doctoral research at RBWH. Dr Taubert, whose PhD program incorporated the development and implementation of a speech pathologyled videofluorosopic referring model of care, was awarded the QuARRIES Fostering Innovation Award and the People's Choice Award at the 2022 Allied Health Translation of Research in Practice Showcase.

In the last 12 months, Speech Pathology and Audiology Department staff have authored 17 peer reviewed publications and disseminated their research in 7 national and 17 international conference presentations. Dr Clare Burns also co-led the development of national professional guidelines on telepractice services for Speech Pathology Australia. We have continued to support 12 department-led research projects and 16 projects in collaboration with other teams. We have strengthened our networks with colleagues in allied health, nursing and medicine at RBWH, and our collaborations within Speech Pathology Services across Metro North HHS, Centre for Functioning and Health Research Metro South Health, RECOVER Injury Research Centre, (UQ), Queensland Aphasia Research Centre (QARC, UQ), School of Health and Rehabilitation Sciences, UQ, the Australian Centre of Health Services Innovation (AusHSI, QUT), and Centre for Applied Economics (Griffith University). Audiology networks have also been established with the National Acoustics Laboratory and private and public cochlear implant clinics nationwide.

Our commitment to developing research capacity and capability has continued to grow with 9 RHD students being supported by the Speech Pathology and Audiology Department. In 2022, 4 staff members progressed their research higher degrees, and 5 PhD students were supervised by speech pathology research staff.
