

## The Viewer

- A read-only web based application that displays consolidated clinical information sourced from a variety of Queensland Health clinical and administrative systems
- Integrates with 70+ systems state-wide
- Having direct access to The Viewer can help optometrists provide a more holistic approach to the management and diagnosis of health disorders involving the eyes.

## Clinical benefits include:

- supports optometrists to make informed medical decisions about patient care based on the latest available clinical information
- provides real-time access to Queensland Health medical information
- · reduces duplication of diagnostic testing
- helps ensure more consistent, timely, and coordinated care









#### Terms and Conditions

In addition to my obligations under the Health Practitioner Regulation National Law (Queensland), I understand and agree that:

- 1. I must access and use the Health Provider Portal (HPP) and access and use information accessible through the HPP ('confidential information'):
- a. strictly in accordance with the HPP Terms of Access and Use, which I agree forms a legally binding agreement (the 'Agreement') between myself and the State of Queensland acting through Queensland Health ('Queensland Health');
- b. only as a Prescribed Health Practitioner acting in that capacity, as permitted under the Hospital and Health Boards Act 2011 (Qld);
- 2. I will not disclose confidential information, except as permitted or required under the Hospital and Health Boards Act 2011 (Qld);
- 3. confidential information, or any part thereof, does not represent an exhaustive and complete health record for any individual;

#### I understand that:

- 1. my activities in the HPP are tracked, logged against my login credentials and may be subject to audit, public scrutiny and disclosure under the Right to Information Act 2009 (Qld);
- 2. my access and use of the HPP is monitored, including for identification of breaches of the HPP Terms of Access and Use and inappropriate and unlawful activity;
- 3. if I breach the HPP Terms of Access and Use, Queensland Health may take action against me under our Agreement;
- 4. if any of my access or use of the HPP, or my dealing with confidential information:
- a. is inappropriate or unlawful, Queensland Health may make a complaint about me under the Health Ombudsman Act 2013 (Qld) and the Health Practitioner Regulation National Law (Queensland);
- b. breaches legislation, I may be found to have committed an offence and/or be subject to penalties, including up to 600 penalty units under the Hospital and Health Boards Act 2011 (Old);
- 5. Queensland Health deals with my personal information collected as a result of my access and use of the HPP in accordance with its Privacy Policy.

## Variances for QH and non-QH staff

There are key differences between what is visible to Queensland Health staff viewing public hospital records in The Viewer and what is visible to non-Queensland Health staff accessing The Viewer such as those accessing via the Health Provider Portal.

## Patient consent and auditing

Patients can opt-out of all health practitioners or choose which health practitioner types to opt-in or out of:

- Patients are currently opted in by default
- Those who have already opted out to all practitioners, automatically applies to optometrists
- Patients can opt back in at any time
- To opt in or opt out call 13 HEALTH (13 432 584)

  Translation and interpreter services can be arranged to assist with the opt-out process.
